**2. Approval of Agenda:** Greg Latreille motions to approve. Seconded by Maureen Hansen.

**3. Approval of Past Meeting Minutes:**

- a. October Minutes. Greg Latreille motions to approve. Seconded by Brad Fristoe. Minutes passed unanimously.
- b. December Minutes with e-mailed changes. Brad Fristoe motions to approve. Seconded by Greg Latreille. Minutes passed unanimously.

**4. Treasurer's Report:** See attached report – Treasurer's Report, 2-10-08.

- a. General – Things are tracking ok. Dues are coming in. Still waiting for February's numbers. They have already exceed the amount of income budgeted but the Sandman profit is still included and we should probably put this money towards something more than offsetting our negative budget.
- b. Pat Coullahan – Proposes that we put the Sandman income aside and save it as budget for the next seminar.
- c. Greg Latreille – The other chapters were told to document what they were doing with the money. Most put the money towards a scholarship. So it would be good if we did a scholarship as well. That way we demonstrate our accountability.

- d. Pat Coullahan – We should finalize what we want to do with the Sandman money at the March meeting. 2 options have been proposed – scholarship or seminar budget.
  - e. 2008 Scholarship – A lot more people applied for last year’s scholarship. Almost double the number of applicants. Hard cuts to make.
  - f. \$25 difference between Greg’s accounting spreadsheet and the Quicken spreadsheet. Money is not really there and will have to be paid back to whoever’s chapter is due. Details described in report.
  - g. 0.16% on savings now.
  - h. Will have a clearer picture of budget next month when more dues come in.
  - i. Katie Swenson motions to approve. Seconded by Maureen Hansen. Treasurer’s report passed unanimously.
- 5. Membership Report:** Greg Latreille will take a look at the membership and the number of delinquents. Will send out an e-mail with list.
- 6. ASPE Calendar Update:** Greg Latreille posted the ASPE calendar to the website. E-week calendar also posted to website. Greg will revise the e-week calendar to state that it is just the calendar for Anchorage.
- 7. Old Business:**
- a. Website – Should put some detail on the ASPE website about continuing education credits and dates. Also, would be great to post the events that we are hosting (like when Art is coming to give seminars). Greg Latreille – Thinks that this should be done on a chapter website. But how are chapters supposed to do this when the state barely got a website? If all the chapters are on the state website then why have additional websites? If all the information is in one place it makes it much easier to use. Would be good to post meetings. Then put the roster of attendees signed by a PE on the website to document people’s presence. That way attendees to the lunch meetings or seminars are documented in case the need to prove their credits. Greg Latreille – Agrees with the ideas for the website, but doesn’t want to manage the NSPE website and 3 chapter websites. He is very busy with treasurer duties and tracking continuing education credits will be a time consuming job. Add topic to March minutes.
  - b. Continuing Education Report – NSPE talking about giving 4 PDHs if member of NSPE. Would be great to have this on the website to promote membership.
  - c. NSPE Fellow Nomination Status – Completed paperwork and sent it to the committee. Now just waiting for announcements.
  - d. 2009-2010 Officers – Proposed roster sent out by Katie Swenson. Katie will send out the ballots and collect votes. Will send ballots to the chapter representatives and other “at large” members. Chapters should send out the ballots to their membership. Want to hear back by February 28<sup>th</sup>. All ballots should be sent directly to Katie. Can reply to ballots in any way; by e-mail, pdf, word, fax. Some people will send their ballots to their chapter reps anyway; forward all to Katie. Usually only 50% vote. Greg will check with Angela Smith on her position before the ballot gets sent out.

## **August Teleconference Treasurer's Report**

### Summary

We have received a large amount of dues in the past two months. We have already surpassed our budgeted income amount for the fiscal year. We budgeted for a significant loss this year, however, so we may still not break even for the year, but with a large push of dues expected for February, it looks like it may be quite close.

### Discussion

There are two discrepancies between the Quicken accounting and my Excel backup. One deals with the \$12,000 that has matured and is waiting for me to either roll over or dump back into savings. The other is yet another error on NSPE's part in giving us a donation check off for someone who belongs to another state. I am in the process of getting both of these issues straightened out, and they should be settled by our March meeting. It would be nice to have it cleaned up before the close of our fiscal year.

We are tracking along pretty well with our budgeted income for the year, and thus far the expenses have been lower than budgeted. It is important to note, however, that the \$3,136.76 income from the Sandman Seminar needs to be allocated toward some specific purpose, and it should not be considered a sum that helps us offset our budgetary losses.
